## **Useful Information**

Resourcing health & Education is a service for the sex industry in Victoria. The service operates from 10 Inkerman Street, St Kilda and provides site based and outreach services in collaboration with relevant programs and agencies. As a program of Inner South Community Health, RhED provides practical health information and supports. RhED offers a variety of different programs for the sex industry including;

# Pathways to Exit (Often referred to as Pathways Program)

The Pathways Program recognises that a career in the sex industry, like any other career, can have an expiry date for some people and that some workers are interested in expanding their opportunities outside of the sex industry. The Program does not put pressure on workers to leave the industry. It is aimed at those workers who want to explore and expand their options external to the industry.

The Pathways Program is a case management service for sex workers who want to explore their education and employment options outside the sex industry. Case Managers can provide support with education, employment, health and housing.

# **Arrest Referral Program**

The Arrest Referral Program offers legal information and support for people charged with sex work or non-violent, drug related offences in the City of Port Phillip. This includes assistance with making contact with the police, assistance with applying for Victims of Crime Compensation and addressing any outstanding fines. Workers can provide support, legal information, and referral and in some cases attend court with you.

# **Health Education & Support Workers**
